 - d. Demonstrates creativity a problem solver, not simply a problem identifier;
 - e. Relates well with others; is respected by industry peers; and is willing to serve as a resource to other PIAFL members:
 - f. Demonstrates open-mindedness and a sensitivity to others' points of view;
 - g. Has a sincere desire to represent the best interests of PIAFL membership.
 - h. A commitment to facilitating communication between the Board, Membership, and program Sponsors;
 - i. A willingness to make a commitment to further the cause of the PIAFL and its Membership;
- 2. Leadership, Governance & Oversight:
 - a. Prior experience with a formal group structure (another Board, Committee, Association, etc.)
 - b. Reviewing agenda and supporting materials prior to board and committee meetings
 - c. Approving PIA's annual budget, audit reports, and material business decisions; being informed of, and meeting all, legal and fiduciary responsibilities
 - d. Partnering with other board members and staff to ensure that board resolutions are carried out
 - e. Serving on committees or task forces and taking on special assignments
 - f. Representing PIA National to stakeholders; acting as an ambassador for the organization
